QuADRANT Survey on Clinical Audit



Introduction

Thank you for agreeing to participate in this important survey on clinical audit which forms a key part of the <u>QuADRANT project</u> undertaken on behalf of the European Commission, led by the <u>European Society of Radiology</u> (ESR) together with the <u>European Association of Nuclear Medicine</u> (EANM) and the <u>European Society for Radiotherapy and Oncology</u> (ESTRO) with input from other key national, European and international organisations.

The survey is not long (ca. 30 questions) and the majority of responses are tick-box, with the opportunity for free text where appropriate. Responses are returned to the office of the ESR where national data will be analysed and later presented at a multidisciplinary QuADRANT conference. The survey findings will form part of a report to the European Commission providing a collection of best practices, guidance and recommendations on improving the integration of clinical audit of medical practice into European healthcare systems. The survey also aims to assess existing healthcare related clinical audit practice as mandated within the European Basic Safety Standards Directive (Council Directive 2013/59/Euratom). The survey looks to identify potential barriers to effective participation in clinical audit and what provisions/changes might facilitate improvement.

The survey is divided into two main sections:

- **Section 1** examines clinical audit processes and infrastructures as part of everyday clinical practice, with an emphasis on the core project disciplines of diagnostic and interventional radiology (also including interventional cardiology), radiotherapy and nuclear medicine (to include therapies).
- **Section 2** relates to the requirement for clinical audit as defined within the European Basic Safety Standards Directive and its enforcement through regulatory inspection.

Participants may complete either Section 1 or Section 2 alone, or they may complete both parts, depending on their individual experience and field of interest. Joint survey completion e.g. by national audit administrative and HERCA (WGMA, working group medical applications) representatives is also encouraged where feasible. The identity of survey responders will be anonymised at the time of presentation. Survey participants are directed towards the accompanying definitions/terms in use section which will facilitate survey completion.

Please note that there is **NO SAVE FUNCTION** on the Survey Monkey platform – **you cannot partially complete the survey and return at a later date**. For this reason, we recommend that you prepare your answers using this PDF of the questions and also the <u>definitions</u> before completing the online survey.
